

<u>Call to Order:</u> George called the meeting to order at 8:30am.

**Public Comments:** Alex noted Aly Eggart's attendance at TBEX and provided details on a few upcoming events.

## **Partner Update:**

<u>Billings Chamber:</u> Toby provided information on the upcoming "You Belong in Billings" campaign, while Jennifer provided staff, program, and building updates.

# **New Business:**

SBURA/Sportsplex Proposed Purchase for Ice Facility/LOS: Dick presented an SBURA plan for a possible Sportsplex purchase that included the facility and land along with retrofitting the facility for an ice sheet, and he explained how this project could work in tandem with the Multi-Generational Sports Facility planning. Alex provided comments from Andy Zoeller and Wyeth Friday which offered insight on the City's view of a possible purchase of the property and concerns. MOTION: Steve motioned for the Billings TBID to provide a letter of support to the Billings City Council for the project; Ron seconded. Motion carried.

Montana Travel Association/FY23 Support: Alex provided an update on the Montana Travel Association (MTTA) and how such advocacy will benefit the industry in the immediate region and state.

MOTION: Ron motioned for the Billings TBID to support the Montana Travel Association in FY23 with \$5,000; Steve seconded. Motion carried.

<u>Voices of Montana Tourism:</u> Steve reviewed the BTBID's previous support for Voices of Montana Tourism (VOMT) and how the VOMT mission differs from that of the Montana Travel Association.

MOTION: Steve motioned to continue to support Voices of Montana Tourism in FY23 with \$12,000; Ron seconded. Motion carried.

<u>Sports Tourism Position and Marketing Information:</u> Alex provided an update on the Sports Tourism Manager position and how current work in this area is being paired with updated marketing information & materials. Alex noted the new Sports Tourism Manager was starting his new role on November 1, 2022.



## **Old Business:**

<u>TBID Funds</u>, <u>Resolutions</u>, <u>and M.C.A. Follow-Up:</u> Steve provided more information on current TBID fund use in other Montanan communities and how the Billings TBID can solidify its mission.

2022 Statewide TBID Meeting Agenda & MLHA/VOMT Luncheon/Billings: The board discussed which items they would like to see on the agenda for the upcoming statewide TBID meeting and other details surrounding the MLHA and Voices of Montana Tourism Legislative luncheon.

<u>Visit Billings Strategic Plan Update:</u> Alex shared an update on the Visit Billings Strategic Plan and the current timeline for the overall project.
